This independently licensed person also provides brief and intensive therapy to individuals, children, adolescents, families, and/or groups, as well as Clinical Supervision to non-independently licensed providers.

**Education:**

Graduation from an approved and accredited school with a master's degree in Social Work, Counseling, Psychology, or other related human service field.

**Licensure:**

Holds a current license in the State of New Mexico at the independent practitioner level such as, but not limited to, Independent Social Worker (LISW) or Licensed Professional Clinical Counselor (LPCC).

**Certification:**

CPR/ First Aid.

**Experience:**

Two-year's post-master's experience working in behavioral health to include crisis counseling.

Master's Degree in Social Work or Counseling Field.  
Clinical Supervision Experience/Supervisory Experience  
Experience with treatment of substance abuse.  
Ability to work with children of all ages and with their families.
